It is our pleasure to announce that on Saturday, April 4th, 2020, Pro Bono Network's (PBN'S) annual benefit, JUSTICE ROCKS will take place at Wire in Berwyn, IL. The event will begin with signature cocktails, a sampling of blues and soul inspired hors d'oeuvres followed by a live performance from the fabulously talented Rhythm and Blues band, Sons of Chicago.

PBN is a one-of-a-kind organization which provides a network of over 400 volunteer attorneys to low income residents in the Chicagoland area. All proceeds from PBN's JUSTICE ROCKS event will benefit PBN's legal aid projects. Our projects include, among other things, filing orders of protection for victims of domestic abuse, helping incarcerated mothers, representing people facing eviction or social security disability proceedings, drafting U-Visa applications for immigrants and preparing Living Wills and Powers of Attorney for seniors. Hiring a private attorney for these types of matters would normally cost on average, thousands of dollars. For our clients, living in economically challenged neighborhoods, this is simply beyond their reach. This is where PBN comes in. Our attorneys work with our clients on a pro bono basis, meaning they volunteer 100% of their time and our clients don't get charged a dime. In 2019, we have already provided assistance to 1,215 clients. Your sponsorship of PBN guarantees, among other things, that those low income seniors, incarcerated mothers, immigrants and domestic abuse victims all have access to talented and dedicated attorneys who can address their legal needs and do so without creating an insurmountable financial burden.
